- (a) if this application is acceded to and following proof of residence in Malta for a period of thirty-six (36) months I decide to submit an application for naturalisation as a citizen of Malta I will make a direct investment to the Republic of Malta for the amount of five hundred and ninety thousand euro (€590,000)\*; or
  - if this application is acceded to and following proof of residence in Malta for a period of twelve (12) months I decide to submit an application for naturalisation as a citizen of Malta I will make a direct investment to the Republic of Malta for the amount of seven hundred and forty thousand euro (€740,000)\*.
- (b) if my application for naturalisation is acceded to I undertake to either purchase, an immovable residential property in Malta having a minimum value of seven hundred thousand euro (€700,000) or to take on a lease of a residential immovable property in Malta for a minimum annual rent of sixteen thousand euro (€16,000), which property shall be adequate and suitable for my dependants (delete if not applicable) and myself for a minimum period of five (5) years from the date of issue of the certificate of Citizenship.
- (c) to undertake to donate, prior to the issue of the certificate of naturalisation, a minimum of ten thousand euro (€10,000) to a registered philanthropic, cultural, sport, scientific, animal welfare or artistic non-governmental organisation or society, or otherwise approved by the Agency.
